6. In the event the person named wishes to withdraw from the course then this may be done up to 14 days before the course commencement date and a charge of 10% of the course value will be forfeited. The balance of 90% of the payment will be refunded. Any withdrawal less than 14 days before the course commencement date will result in loss of the complete amount.
